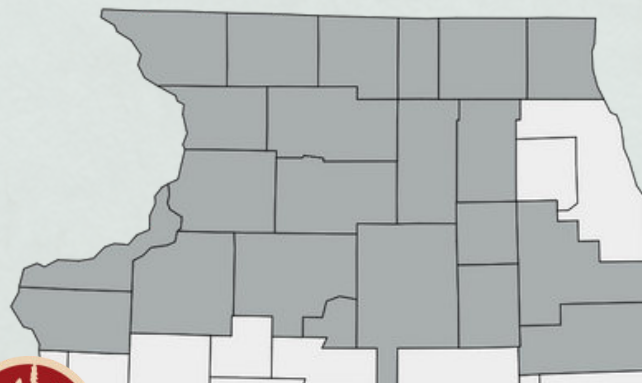

# Engagement

Members are actively engaged at all levels, which creates connections and advances the organization.

- **PUG Day 2024 | Virtual:** 603 total webinar attendees from 74 member libraries (54% participation) | 15 live virtual sessions
- **Spring 2025 Member Updates:** 1 virtual meeting with 29 attendees | 4 in-person meetings across the membership region with 31 total attendees
- **10 Governance and Standing Committees:** 46 meetings throughout the fiscal year
- **Site Visits with Member Libraries:** 26 in-person site visits
- **Resource Sharing Summit:** Marketing Your Library | 47 participants
- **New Director Welcome:** 4 sessions with 25 total participants
- **Union List Members Meeting:** 10 participants from Union List members
- **Back to School Session:** 18 participants from school libraries

# Training

Learning opportunities equip members to provide excellent service to end users.

## PrairieCat Led Sessions

## Talent LMS Courses

61 self-paced courses  
2,963 courses completed | 519 users

- **TalentLMS:** Self-paced courses available 24/7 through PrairieCat's online training platform. PrairieCat trainings offered online include searching, holds, circulation, and cataloging.
- **Item Entry Certification:** 48 library staff completed Item Entry Certification through TalentLMS. PrairieCat requires that any staff that adds new items to the PrairieCat database are item entry certified to help maintain the accuracy of the database.
- **Create Lists Training:** 22 library staff completed the training through TalentLMS. Create Lists is available to Fully Participating members and the training must be completed to use this Sierra function.
- **Vega Discover:** 4 new Vega Discover courses were launched with 298 course completions. The Showcases and User Roles courses allow for library customizations of their Vega sites.
- **IPLAR Q&A:** PrairieCat offered 4 IPLAR Q&A sessions that 29 members attended.



# User Experience

Members are supported in their efforts to provide exceptional service to end users.

- **Innovative Interfaces:** PrairieCat staff beta tested and launched the User Roles and Permissions feature in Vega Discover allowing for library customizations using showcases and homepage builder.
- **Mobile App:** The User Experience Committee reviewed vendors for the mobile app and after thorough review made a recommendation to use Innovative Vega Mobile. The Delegates approved the mobile application contract with implementation scheduled for FY26.
- **Website Member Forums:** PrairieCat launched website member forums for peer-to-peer discussions around library services.
- **Fine Free Libraries:** 3 PrairieCat libraries went fine free during FY25 bringing the total to 61. PrairieCat staff provided system support and resources to make these changes possible.

# Governance

Leadership is transparent, responsive, innovative, and accountable.

- **Delegates Assembly:** 85% voting member attendance rate
- **FY26 Administrative Council and Committees Election:** 49% member participation
- **New Directors:** PrairieCat welcomed 11 new directors at member libraries in FY25.
- **Membership Changes:** Manhattan-Elwood Public Library District opened a new branch in November 2024. Mills and Petrie Memorial Library and Gymnasium went live as a Basic Online member in May 2025. Maple Park Public Library District moved from a Fully Participating to Basic Online membership level.
- **Strategic Planning:** The Delegates approved the new Strategic Plan, which was updated based on staff and member feedback.
- **Sustainability:** RAILS grant funds accounted for approximately 28% of PrairieCat budgeted revenues in FY25 in addition to in-kind services.
