### MEMBERSHIP LEVELS

**Fully Participating Member** – a library that has use of all member functionality within the PrairieCat software. Fully Participating members are voting members and may hold any office.

**Basic Online Member** – a library that has use of all basic circulating, cataloging and online catalog functionality within the PrairieCat software, but not all of the modules available to Fully Participating members. Basic Online members are voting members and may hold any office.

**Union Listing Member** – a library that contributes its holdings to the database for resource sharing activities only and has limited use of member functionality within the PrairieCat software. The Union Listing members select four members to be the group's representatives at governance meetings. Each of the four representatives have voting privileges at Delegates Assembly meetings.

### GOVERNANCE

The affairs of PrairieCat are managed by the **Administrative Council**, an eleven member board elected by the Basic Online and Fully Participating members. The Council sets policy, receives and approves recommendations from standing groups, oversees fiscal operations, and makes recommendations to the Delegates Assembly for purchases over \$20,000 outside the approved budget.

The **Delegates Assembly** of PrairieCat consists of a representative from each Fully Participating and Basic Online Member as well as four Union Listing representatives. The Delegates Assembly provides input to help shape Administrative Council decisions, approves the budget, approves new members, approves the PrairieCat strategic plan, and votes for open seats on the Administrative Council.

## **PrairieCat Brief History**

Prairie Area Library System (PALS) was formed in 2004 by the merger of the Heritage Trail Library System (HTLS), the Northern Illinois Library System (NILS) and the River Bend Library System (RBLS). Originally, PALS staff served four library shared catalogs, Heritage Automated Libraries (HAL), Northern Illinois Catalog (NIC), NILSCatT (a CD-Rom union list catalog for non-circulating members), and Quad-Cities Libraries in Cooperation (Quad-LINC).

PrairieCat was formed in 2007 by the merger of HAL, NILSCatT and Quad-LINC. Some of the former NIC libraries also migrated to PrairieCat at that time, along with a group of previously standalone libraries. PrairieCat was originally on a SirsiDynix Symphony system using IBistro for the public catalog. PrairieCat also briefly used AquaBrowser as a catalog overlay.

In December 2011, nineteen libraries in the Quad-Cities area pulled out of PrairieCat to form RiverShare. In June 2012, six libraries in the Joliet area pulled out of PrairieCat to form Pinnacle Library Cooperative. In May 2016, the eight Illinois public libraries previously in RiverShare rejoined PrairieCat. In May 2019, the eight former NIC libraries will go live on PrairieCat.

PrairieCat migrated to Innovative's Sierra platform in July 2012. PrairieCat added the Basic Online level of membership in 2013 which has encouraged a number of Union List members to move up to fully circulating on the system. FY15 was the first year where the fully circulating members of PrairieCat outnumbered the Union List members.

Since 2006, PrairieCat has administered certification tests for Illinois Statewide Cataloging Certification. To date, more than 500 staff have been barcode certified, and nine staff have been MARC cataloger certified.
